4 - First Aid Measures

Ingestion (Swallowed): Aspiration Hazard. DO NOT induce vomiting. Call physician, poison control center or the WD-40 Safety Hotline at 1-888-324-7596 immediately. 24 hours Hotline of Emergency Service for Chemical Incident in China: 0532-83889090.

Eye Contact: Flush thoroughly with water. Remove contact lenses if present after the first 5 minutes and continue flushing for several more minutes. Get medical attention if irritation occurs and persists.

Skin Contact: Wash with soap and water. If irritation develops and persists, get medical attention.

Inhalation (Breathing): If irritation is experienced, move to fresh air. Get medical attention if irritation or other symptoms develop and persist.

Most Important Symptoms (acute and delayed): Harmful or fatal if swallowed. If swallowed, may be aspirated and cause lung damage. Direct contact may cause eye irritation. Prolonged skin contact may cause drying of the skin. Inhalation of mists or vapors may cause nasal and respiratory irritation and central nervous system effects such as headache, dizziness, and nausea.

Indication of Immediate Medical Attention or Special Treatment: Immediate medical attention is required for ingestion.

5 - Fire Fighting Measures

Extinguishing Media: Use water fog, dry chemical, carbon dioxide or foam. Do not use water jet or flooding amounts of water. Burning product will float on the surface and spread fire.

Special Fire Fighting Procedures: Firefighters should always wear positive pressure self-contained breathing apparatus and full protective clothing. Cool fire-exposed containers with water. Use shielding to protect against bursting containers.

Unusual Fire and Explosion Hazards: Extremely flammable aerosol. Contents under pressure. Keep away from ignition sources and open flames. Exposure of containers to extreme heat and flames can cause them to rupture often with violent force. Vapors can cause a flash fire. Vapors are heavier than air and may travel along surfaces to remote ignition sources and flash back. A vapor and air mixture can create an explosion hazard in confined spaces.

6 - Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures: Eliminate all sources of ignition and ventilate area. Wear appropriate protective clothing (see Section 8).

Environmental Precautions: Report spills to authorities as required.

Methods and Materials for Containment/Cleanup: Leaking cans should be placed in a plastic bag or open pail until the pressure has dissipated. Contain and collect liquid with an inert absorbent and place in a container for disposal. Clean spill area thoroughly. Report spills to authorities as required.

7 - Handling and Storage

Precautions for Safe Handling: Avoid contact with eyes and skin. Avoid breathing vapors or aerosols. Use only with adequate ventilation. Keep away from heat, sparks, pilot lights, hot surfaces, and open flames. Unplug electrical tools, motors, and appliances before spraying or bringing the can near any source of electricity. Electricity can burn a hole in the can and cause contents to burst into flames. To avoid serious burn injury, do not let the can touch battery terminals, electrical connections on motors or appliances or any other source of electricity. Wash thoroughly with soap and water after handling. Keep containers closed when not in use. Keep out of the reach of children. Do not puncture, crush, or incinerate containers, even when empty.

Conditions for Safe Storage, including any incompatibilities: Store in a cool, well-ventilated area, away from incompatible materials. Do not store in direct sunlight or above 120°F. U.F.C (NFPA 30B) Level 1 Aerosol. Store away from oxidizers.

10 - Stability and Reactivity

11 - Toxicological Information

Symptoms of Overexposure:

Inhalation: High concentrations may cause nasal and respiratory irritation and central nervous system effects such as headache, dizziness, and nausea. Intentional abuse may be harmful or fatal.

Skin Contact: May cause skin irritation with short-term exposure with redness, itching and burning of the skin. Prolonged and/or repeated contact may produce defatting and possible dermatitis.

Eye Contact: Contact may be irritating to eyes. May cause redness and tearing.

Ingestion: This product has low oral toxicity. If swallowed, this material may cause irritation of the mouth, throat, and esophagus. Swallowing may cause gastrointestinal irritation, nausea, vomiting, diarrhea, dizziness, drowsiness, and other central nervous system effects. This product is an aspiration hazard. If swallowed, can enter the lungs, and may cause chemical pneumonitis, severe lung damage and death.

Chronic Effects: Prolonged or repeated skin contact may defeat the skin resulting in irritation and dermatitis. **Medical Conditions Aggravated by Exposure:** Preexisting eye, skin and respiratory conditions may be aggravated by exposure.

Carcinogen Status: None of the components are listed as a carcinogen or suspect carcinogen by IARC, NTP, ACGIH or OSHA.

Reproductive Toxicity: None of the components is considered a reproductive hazard.

Numerical Measures of Toxicity:

The oral toxicity of this product is estimated to be greater than 5,000 mg/kg based on an assessment of the ingredients. This product is not classified as toxic by established criteria. It is an aspiration hazard.

12 – Ecological Information

Ecotoxicity:

No specific aquatic toxicity data is currently available; however, components of this product are not expected to be harmful to aquatic organisms. If applied to leaves may kill grasses and small plants by interfering with respiration and transpiration. This product is not toxic to fish but may coat gill structures resulting in suffocation.

Persistence and Degradability: Components are expected to be biodegradable.

Bioaccumulative Potential: Bioaccumulation is not expected based on an assessment of the ingredients.
